- ✧ The College offers private Tuition Loans for 65% of Tuition.
- ✧ RSC Loans are not government subsidized or bank loans.
- ✧ Payments are managed in-house by helpful RSC staff.
- ✧ All monthly Loan payments must be made by debit or credit card.
- ✧ Interest and fees make this service available to our students.
- ✧ RSC Loans are not available for taking workshops, auditing courses, or for students taking only part of a program.
